



OWIN - MEMBERSHIP AGREEMENT

The Membership Agreement (the “Agreement”) is effective as of (date) __/__/__, by and between OWIN – Open Worldwide Innovation Network, having an office at 800 Raymond Stotzer Pkwy – STE 2020 , College Station, Texas, USA and (the “Member”) _____ having an office at (address) _____, (city) _____, (state) _____ (country) _____.

MEMBERSHIP

OWIN has three levels of membership: Executive, Corporate, and Associate. The fee applicable to the Member is dependent on circumstances particular to the Member. Member warrants that it qualifies for the fee agreed upon below.

The Member hereby agrees to join OWIN and to pay the applicable Member Fee for the level of membership designated per this agreement. The OWIN Member Fee is due at the time the organization executes this Agreement. Except as provided for in this Agreement the OWIN Member Fee is non-refundable and shall be payable to OWIN in the currency stated.

The Membership Fees are described in the Appendix.

TERM OF MEMBERSHIP

The OWIN Membership shall begin the day this Agreement is executed and shall continue in force for one (1) year from the first day of the Effective Date falls.

Thereafter, this Agreement shall automatically renew for successive one-year terms beginning on the Effective Date unless the Member notifies OWIN ninety (90) days prior to expiration of the then-current Renewal Term of their intent not to renew this Agreement.

For Renewable Member Fee, the Member agrees to pay the agreed upon Annual Fee for the level of membership indicated per this agreement unless changed by the Member per a 90-day notification to OWIN. The Annual Fee shall be due on or before the Effective Date of this agreement annually.



USE OF MEMBER FEES

OWIN shall use the Member Fees for administrative responsibilities and daily operations of OWIN as well as project management of OWIN initiatives and projects.

APPENDIX

Open Worldwide Innovation Network – is an international business membership association that builds on the successes of its members. OWIN’s members have access to the collective resources of the executive members and of the network. The following are the membership categories:

Executive Level - \$25,000 annually. These Members actively look to develop their region’s economy through emphasizing technology commercialization. Executive-level benefits are as follows:

- All benefits described in the Corporate, Associate and Assistant levels; and a:

Seat on the Board of Directors (BoD). The BoD provides strategic guidance, leadership, and a vision for the direction of OWIN. A designated leader of each executive level member will be a member of the BoD, and participate in Executive Level board meetings in overall leadership of the network. An Executive Level member must meet the following criteria:

(1) have access to sufficient funds to support the creation and growth of companies affiliated with or members of the corporation; (2) have the ability to develop particular programs for innovative companies, members, and affiliates of the corporation; (3) have the demonstrated support of the Executive Member’s community; (4) have the ability to provide or have access to business incubation space that is locally available to the Executive Member; (5) have access to service providers for new companies seeking to locate to the Executive Member’s region; and (6) maintain a contact person for coordination with the corporation on matters affecting the corporation and the Executive Member. Executive members are entitled to appoint one voting director to the Board of Directors of OWIN.

Corporate Level - \$10,000 annually. The corporate Members join to broaden their market reach and grow their organizations awareness globally. Benefits are as follows:

- Opportunity for promotion of your organization at OWIN events

Associate Level - \$5,000 annually. These members provide tremendous value to the network in the form of business incubation, local networks, and access to resources. Benefits are as follows:

- Associate-level Members receive all of the benefits described below for Assistant Members in addition;



- Participation in any OWIN Trade delegation: OWIN regularly coordinates, facilitates, and participates in trade delegations to our member's countries.
